If it cannot be repaired or parts are unavailable, we may replace the complete item with the same or similar item having a retail purchase price less than or equal to the original purchase price of the affected item.

## WHAT YOU NEED TO DO

**Call each time an accident occurs.** Allowing damages or stains to accumulate without notifying ProtectAll will result in a denied claim. You must call within 30 days of discovering the damage.

#### **EXCLUSIONS APPLY**

- Build-up/accumulation; when damages or stains have been allowed to accumulate. You must call each time an accident occurs, within 30 days of discovering the damage.
- General soiling; **PEACE OF MIND** is not a routine fabric cleaning service.
- Loss of foam resiliency, softening of cushions.
- Pet damage from chewing and scratching.
- Damage resulting from abuse.
- Cracking and peeling, loss of color, build up of body oils on leather (including bonded and other imitation leather surfaces).
- Odors and fading.
- Pilling or fraying of fabrics; shedding & pulls on fabric & area rugs.
- Scratches that do not penetrate the wood finish.
- Scratches to leather, upholstery, or glass surfaces.
